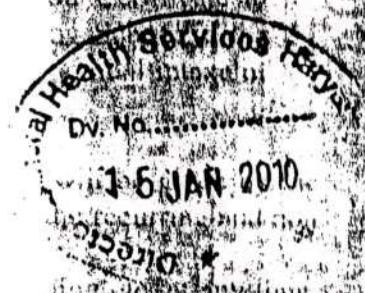

Subj: No Objection certificate for opening of GNM Training School to Bangar Education Trust, Uchana(Jind) in the name of Birender Singh College of Nursing, Uchana (Jind).

Reference your letter.No. 27/656-4 Nursing/215, dated 18-11-2009 on the subject noted above.

2. The Government has decided to issue No Objection Certificate to Bangar Education Trust, Uchana(Jind) for starting to GNM Training School in the name of Birender Singh College of Nursing at Uchana (Jind) with annual intake of 60 seats subject to the following conditions:-

1. No financial assistance/grant in any case in any form will be given by the State Government. The institution will have to bear all the recurring and non recurring expenditure for all time to come.
2. The State Government shall not give any grant for building etc. at any time. The building intended for educational occupancy will not be used for any hazardous occupancy.
3. The State Government shall not take over the school at the request of the institution.
4. The institution shall seek approval from INC/HNC/affiliated from the concerned university before making admission and send the copy of the approval/affiliation to this office.
5. All the conditions of affiliation prescribed by the affiliating University/INC/HNC will have to be met by the institution.
6. The college authorities will recruit the staff as per Government/University/INC/HNC guidelines and pay the salary to the staff in the pay scale prescribed by the Government from time to time.
7. Tuition fee and other charges will be as per the norms of the affiliating University/INC/HNC.
8. In the admission of the students there shall be reservation of seats for SC/BC/OBC, handicapped, ex-servicemen, sports persons, Freedom Fighters and any other reserved category as per the State Government policy.
9. The Government can impose any other conditions at any time, which shall be binding on the institution.
10. In case the institution is not able to run/sustain itself, the NOC shall be withdrawn and the FDR/Bank Guarantee submitted by the Applicant shall be forfeited to continue the studies of the enrolled students/payment of the salary of the Staff and for other costs of running the institute and in case the funds available in the school/College are not sufficient the balance amount shall be recovered from the applicant society/trust/company/individuals as per the Law of the State.
11. The institution will construct its own hostel within the period of one year from the date of issuing this NOC.
12. Any contravention of the above stated conditions shall result in withdrawal of the "No Objection Certificate" and legal action against the defaulting society/institution.
